Unvested stock options vest in installments as follows: (a) 7,398 options on each of January 29, 2022 and January 29, 2023, and 7,399 options on each of January 29, 2024 and January 29, 2025; and (b) 8,220 options on the first anniversary of the closing of the Issuer's initial public offering (the "IPO"), and 8,221 options on each of the second anniversary of the closing of the IPO and on the 273rd day following the second anniversary of the closing of the IPO, subject to earlier forfeiture or acceleration.
